Depression of cortical function causing loss of judgement, emotional lability, muscle incoordination, visual impairment, slurred speech, and ataxia. Hangover effects may include nausea, headache, dizziness, and tremor.

#### **Treatment:**

Contact a doctor. Empty the stomach by aspiration and lavage. Haemodialysis is of value in severe alcoholic poisoning.

Castor oil or olive oil may be added to the water to dissolve thymol and delay absorption; 50

ml of oil may be left in the stomach. Keep the patient warm and treat pulmonary oedema,

systemic acidosis, respiratory failure, and circulatory failure symptomatically. Respiration

may have to be assisted. Haemodialysis is of value in severe alcoholic poisoning.
