4. Clinical Particulars

4.1 Therapeutic Indications

For relief or treatment of:

- Minor skin irritation, itching, and rashes due to eczema, insect bites, poison ivy, oak, or sumac dermatitis, detergents, cosmetics and jewellery.
- Anogenital pruritus

4.2 Contraindications

- Excessive or prolonged usage in pregnancy is not recommended.
- Avoid contact with eyes.
- It should not be applied to ulcers of the leg.

4.3 **Posology and Method of Administration**

Apply sparingly to the affected area.

Adults : Three or four times a day. Children : One or two times a day.

4.4 Special Warning and Precautions for Use

- Caution in patients with infection at treatment site, and tuberculosis of the skin.
- Pediatric therapy continuing for longer than 2 weeks should be evaluated carefully by the physician.
- Do not bandage or otherwise wrap the treated skin area unless directed to do so by physician.
- Safety for use in lactation has not been established.

4.8 Undesirable effects

Increase liability to infection; prolonged use include moon face, glaucoma, thinning of skin with easy bruising, increase in hair growth, loss of hair, reddish purple lines on arms, legs, trunk, or groin.

Note: It has fewer side-effects on the skin than the more potent topical corticosteroids.

4.9 Overdose

Clinical features:

Atrophic changes in the skin, secondary infections, burning, itching, irritation, dryness, folliculitis, hypertrichosis, acne, and pigmentation.

Treatment for overdosage:

Treat overdosage by symptomatic measures, where possible the dosage being reduced or the drug slowly withdrawn.

5. Pharmacological Properties

5.1 Pharmacodynamic Properties

The anti-inflammatory effect of topical application of hydrocortisone, a less potent corticosteroid, is due to its ability to diffuse across cell membranes and subsequently enters the cell nucleus. It then binds with DNA, and stimulates transcription of messenger RNA resulting in protein synthesis of various enzymes.

5.2 Pharmacokinetic Properties

It is absorbed percutaneously, particularly in denuded areas. Occlusion or use over extensive areas increases topical absorption.
