SUMMARY OF PRODUCT CHARACTERISTICS

1 NAME OF THE MEDICINAL PRODUCT

Salonpas Pain Relief Patch, Patch
Methyl Salicylate 10%/ Levomenthol 3%

2 QUALITATIVE AND QUANTITATIVE COMPOSITION

Each patch (7cm ×10 cm) contains 10% Methyl salicylate and 3% Levomenthol.
For excipients, see section 6.1.

3 PHARMACEUTICAL FORM

Patch for topical application.
70 cm² patch.

4 CLINICAL PARTICULARS

4.1 Therapeutic indications

For relief of aches & pains associated with: sore shoulder, stiff neck, backache, muscle pain, joint pain, arthritis, strains, bruises, sprains.

4.2 Posology and method of administration

For adults and children 12 years of age and over :

Clean and dry affected area.

Remove film from patch and apply to skin.

Do not use more than a total of 4 patches on different parts of body per day.

Use only 1 patch at a time per affected area.

Leave an individual patch in place for up to 12 hours.

Do not use patches for more than 5 days in a row.

For children under 12 years of age :

Consult a doctor.

4.3 Contraindications

Do not use on wounds or damaged skin. Do not use if you are allergic to any ingredient of this product.

4.4 Special warnings and precautions for use

For external use only.

Ask a doctor before use if you are allergic to external application products.

When using this product, use only as directed and avoid contact with the eyes, mucous membranes or rashes.

Stop use and ask a doctor if conditions worsen or symptoms persist for more than 5 days or clear up and occur again within a few days.

Stop use and ask a doctor if skin reactions such as redness, itching, rash, excessive irritation, burning sensation, swelling or blistering occur.
